In an effort to promote Michigan fine art, HVCA is offering an opportunity for Michigan artists, individual or groups, to exhibit their work in our Highland Station House Gallery for a period of one month during the 2011 gallery season. The HVCA will promote the featured artist by providing all promotional advertisement, posters and hosting an opening night reception with refreshments.

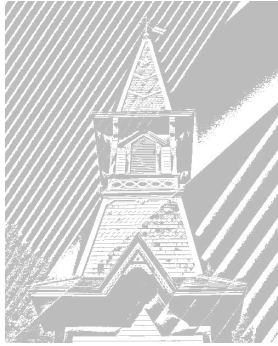
ELIGIBILITY:

Participation is open to all Michigan artists 18 years or older. Works in all media will be considered. All artwork must be original, created solely by the artists and have been completed within the last two years **Works cannot exceed 48 inches in any direction.** Entries must be postmarked no later than 9/1/10. Any artwork previously exhibited at HVCA is **not** eligible. All exhibited work must be for sale.

ENTRY DETAILS:

Submit a one page bio, resume, CD with a maximum of ten jpegs or ten 4 X 6 inch photos representing current work, and a non-refundable jury fee of \$45.00 to: HVCA, P.O. Box 999, Highland, MI 48357. All entries must be postmarked no later than 9/1/10. Later entries will be returned unopened. **NOTIFICATION OF ACCEPTANCE WILL BE MADE BY 9/24/10.**

ENTRY FORMAT:

Entries will be judged from high resolution electronic images or color prints (4" X 6"). Electronic files must be in jpeg or pdf format, minimum of 300 dpi. Submit files on a CD. Label the CD with the artist's name and telephone number. Name electronic files as follows:

A_title of work.jpeg

B_title of work.jpeg

C_title of work.jpeg

D_title of work.jpeg

E_title of work.jpeg

Abbreviate as needed on the electronic file name, but be sure the entry form has complete information. Photo images must be clearly marked on the back with the artists name, artwork title and dimensions. Photos and CDs will **NOT** be returned.

PRESENTATION:

If selected for an exhibit, all artwork must be delivered ready for presentation. Framed artwork must be delivered with appropriate glass or plexiglass and properly secured hanging wire. Artwork delivered unprepared for presentation WILL NOT be accepted.

INSURANCE:

The HVCA will exercise all reasonable care with your original artwork. However, the HVCA, its directors, members, volunteers and/or anyone connected with the exhibition will not be responsible for the loss or damage to artwork. It is suggested the artist carry insurance.

SALES & COPYRIGHTS:

A commission of 25% will be charged on all artwork sold. Your entry grants HVCA permission to photograph your work and to use your images for promotional or educational purposes only. Further, your submission of artwork shall constitute an agreement to comply with all conditions set forth in this prospectus. The jurors reserve the right to reject any artwork not accurately represented by photos or electronic image. The decision of the jurors is final. All accepted artwork will remain as placed by the installation committee and may not be withdrawn before the close of the exhibit.
